Our groups and the constituencies we represent are each uniquely concerned, and many directly impacted, by the spending scheme contemplated by this budget resolution. This legislative framework will lead to policies that slash resources and raise costs for everyday workers and families in order to pad the pockets of the wealthy through lucrative contracts and exorbitant tax cuts, terrorize immigrants and their families, and harm the environment. The budget resolution is a non-starter for our communities.

Because we are a diverse collection of interests, each of our organizations may not take the exact same position on every aspect of this wide-ranging bill. However, we are firmly united in our conclusion: to protect families, communities and our future, members of Congress should vote against this dangerous budget resolution.
