# FORMER FEDERAL AND STATE CIVIL SERVANTS ANALYZE TRUMP ADMINISTRATION'S PROPOSALS FOR EPA'S FY2018 BUDGET

The Environmental Protection Network, a newly formed group of former federal and state employees and other environmental professionals, has produced a detailed analysis of the Trump Administration's proposals for the FY2018 budget for the Environmental Protection Agency and concluded that —

The Trump Budget Blueprint for EPA appears to be nothing less than a full-throttle attack on the principle underlying all U.S. environmental laws – that protecting the health and environment of all Americans is a national priority.

The Network's analysis assesses the consequences for EPA and state programs of the cuts proposed in the President's Budget Blueprint released on March 16, 2017. Since the Budget Blueprint provides few details about specific cuts, our analysis also considers the more detailed information in the "Passback" that OMB previously sent EPA as part of the confidential budget development process. Many of the Passback's proposed cuts have been reported, but our analysis draws on additional information we have obtained about the Passback. We believe the Passback continues to provide important insights into the Administration's plans for EPA.

It is important to note that the Budget Blueprint calls for even more draconian cuts to EPA's budget and staffing – 31% and 21% respectively – than did the Passback. The specific program cuts underlying the Blueprint's overall cuts must thus be generally deeper than those indicated in the Passback.

The size of proposed cuts detailed in the Passback vary by program, with 38 programs eliminated, others cut by half or more, and many others that are *not* related to infrastructure cut by 10-35%. The Budget Blueprint ups the ante by targeting more than 50 programs for elimination and deepening the cuts to state agency funding by 45% compared to the Passback's proposed cut of 30% in most grant categories. Deeper cuts to other programs are likely to be revealed when the Administration's detailed budget is released in May.

The Network's analysis summarizes the impacts of the proposed budget and staffing cuts, provides historical perspective and describes the federal-state partnership embedded in many U.S. environmental laws. It also assesses the impacts of cuts on EPA's current programs for climate protection, clean air and water, safe waste disposal and use of chemicals, science and research, enforcement and protection of significant water bodies and vulnerable communities.
